New Omega ATS Liquidity Provider Program

Tradelogiq Markets Inc. is pleased to announce the introduction of a new liquidity provision program (“**LP Program**”) for Omega ATS that will replace the existing Breakpoint Pricing program. The new LP Program is designed to better incent liquidity provision on Omega ATS through higher discounts, more accessible trading activity tiers, and improved alignment between activity and rewards. This should further strengthen the depth and breadth of liquidity on Omega ATS, and also result in better execution quality and lower trading costs for dealers that route their active order flow to Omega ATS.

Tradelogiq has filed the related changes to its fee schedule and, subject to regulatory approval, Omega ATS will introduce the LP Program on October 1, 2022.

The new LP Program will continue to allow participants to earn reductions in their provision costs by meeting certain trading thresholds, but will incorporate the following key changes:
